This table is collected from multiple sources and from the work of others. It was started in February 2010 to provide a document containing leads for others doing genealogical/historical research and to which they can add updated/confirmed information. Clearly it is a work in progress. There are several individuals included here that were not in Co. C (also called Co. E for a time) to my knowledge. They are included here because the letters of Capt. Voigt frequently mention them, which could cause confusion for a new researcher, or because a source said they were in Company C, but I was unable to confirm this. In some cases men were transferred in and out of the company or the records or other research accounts seem to imply this was the case. References are included so that researchers may go to the source of the information.

The company recruiting started on March 22, 1862 in Industry, TX. Capt Voigt was a businessman there and in Houston. Further recruiting was done in Bellville, TX, and the officers and non-commissioned officers were elected there. The unit then went on to Hempstead and then Houston, TX, probably adding recruits along the way. Some of Voigt's Houston friends or their relatives joined the unit in Houston. The unit was sworn into service on April 4, 1862 in Houston, and reached Camp Waul near Brenham on May 21, 1862. During training at Camp Waul, new recruits were added to the company, and some men were transferred in and out of the company. The unit left Camp Waul on August 18, 1862, and they were ultimately told to to join the Mississippi Campaign. All company operations remained in Mississippi. After arriving at Camp Coldwater above Holly Springs around October 11, 1862, the men received uniforms and muskets that had been converted from flintlock to percussion. The active Company was surrendered to Union forces just outside Yazoo City, MS, in the early morning hours of July 14, 1863. Many company members were captured in Yazoo City hospitals on July 13th. Major General Francis J. Herron reported to General Grant on July 16, 1863, that of the Confederates captured at Yazoo City, he sent the well prisoners down by boat to Vicksburg (122 privates & 7 officers) and paroled 1 officer & 146 men from the hospitals. (From Official Record of the Union & Confederate Armies, Series I, Volume 24, Part III, pages 519-520)

In earlier versions of this roster, I included two captured Confederate Seamen and a captured sutler. After finding the receiving log at Camp Morton (Ref. 32), I found there were more seamen and many soldiers from the

29th North Carolina Infantry captured at the same time as Company C at Yazoo City. For this reason, I have decided to limit this to only Company C information.
